

National Electrical Code[®] Changes - 2023 (2 Days)

2 Days, 1.4 CEUs

The National Electrical Code[®] (NEC) is updated on a three year cyclical basis. Each edition must be revised because of the continuous introduction of new technologies into the marketplace and the release of new research results by various public and private groups.

This course discusses major revisions in the 2023 edition and explains substantiation for those changes. There are Code wide changes which include the movement of all definitions to Article 100. Understanding the reason for these updates enables personnel in the electrical field to more readily comprehend and implement new rulings for the safe installation of electrical systems and equipment.

This course is intended for electricians, electrical inspectors and contractors who need to meet federal, state and local requirements for installing electrical equipment.

Lab and Classroom Attire

AVO is committed to the personal safety of each participant and requires long pants and ANSI rated “safety toe” work shoes for class and lab activities. Lecture courses may involve a tour of a work or shop area and for this reason open toe shoes and shorts are not considered appropriate attire for the classroom.
